

- That the proponent shall conduct orientation for resident engineers and contractor who will undertake and implement the project, to apprise them of the conditions/stipulations of this ECC and the necessary measures that will mitigate adverse environmental impacts, and submit report within 15 days from date of orientation;
- 2. That a billboard measuring at least 0.5 m. x 1.0 m. bearing the following message: "Notice to the Public that this project "Cityland Makati Executive Towers (II, III and IV) of Cityland Development Corporation has been issued an Environmental Compliance Certificate (ECC NCR 2003- 09 10 -516-216) by the Department of Environment and Natural Resources, EMB-NCR on SEP 1 2003 "shall be installed at all entry/exit points of the project site facing the road;
- 3. That the proponent shall allocate funds or provide financial requirements of the Multi-Partite Monitoring Team (MMT) to be formed within thirty days after the issuance of the ECC. The MMT should include representative from the neighborhood, EMB-NCR, project proponent and the concerned Local Government Unit (LGU). Likewise, DENR-EMB-NCR shall be officially informed about the composition of the MMT within fifteen days from the date of its formation;
- 4. That the proponent shall comply with the requirements of Republic Act 6969 otherwise known as the "Toxic Substances Hazardous and Nuclear Waste Control Act of 1990" for the handling, storage and transport of used asbestos roofing materials, dismantled from the demolished structure.

II. OPERATION STAGE:

5. That this Certificate covers three (CMET II-28 storey, CMET III-38 storey and CMET IV-26-storey) commercial and residential condominium building with a total gross floor area of 122,111.93 square meters, with complete amenities, basic utilities and special facilities; any modification from the approved project scope shall be officially relayed to this Office for information, evaluation and approval;

III. OTHERS:

- 6. That all the proposed mitigation measures contained in the Environmental Management Plan (EMP) shall be effected;
- 7. That the formal transfer of the responsibility of complying with the stipulations of the ECC from the proponent to the Condominium Corporation shall be incorporated in the Deed of Restrictions to be issued;
- 8. That should adverse environmental impacts occur as a result of project operations, all the activities causing the same should be temporarily stopped until such time that adequate remedial measures have been effected;
- That the project proponent shall allow DENR-EMB-NCR personnel with proper identification card and travel/mission order to conduct inspection/ monitoring in the entire premises without prior notice to oversee compliance to ECC conditions;
- That the transfer of ownership and/or change of name of the project carries the same conditions in this ECC for which written agreement shall be made, copy furnish this Office of the said document for record purposes;
- 11. That this Certificate shall be posted in a conspicuous place in the Administration's Office for easy reference and guidance;
- That a report under oath on the results of monitoring proposed under the Environmental Monitoring Plan of the IEE shall be submitted to this Office annually;
- 13. That a written notification shall be made to the DENR-EMB-NCR, for approval, in case the project proponent cannot comply with any of the conditions for technical reasons; and
- 14. That in case of abandonment or indefinite work stoppage the project proponent shall submit a written notification thirty (30) days before the scheduled abandonment/work stoppage and to restore the site to its original condition or provide safety and protective measures to prevent adverse environmental impacts that may be caused by the project.

This ECC is not a permit rather it is a certification that the proponent has committed to undertake or implement mitigative measures to reduce the negative environmental impacts to acceptable level.
